

**CITY OF MECHANICVILLE TOWN OF STILLWATER
INDUSTRIAL DEVELOPMENT AGENCY
ANNUAL REPORT FOR THE YEAR ENDED DECEMBER 31, 2021**

The Annual Report for 2021 as required by the NYS Public Authorities Accountability Act (PAAA) follows:

OPERATIONS IN 2021

During 2021 the Agency approved financial assistance for an additional project following a public hearing. The project is a Warehouse located in the Town of Stillwater. The project was approved in 2021 and will close in 2022.

The ELP Solar Project was approved in 2019. The project closed in September of 2021 and paid a closing cost of \$160,000 of which \$50,000 was a contractual administrative fee in association with client/project application to SEDC (Saratoga Economic Development Corporation).

The Agency billed a PILOT on four phases of two Agency project companies in 2021. The total PILOT billed, received and distributed to the taxing authorities was \$309,087.87, with the breakdown of one company billed, received and distributed \$294,947.87 and the other \$14,140.

COMPLIANCE WITH PAAA

The Agency has a CEO who was appointed several years ago who continues to serve the Agency, and a CFO who was appointed in 2019 who also continues to serve the Agency. All Agency Board members have completed required training in compliance with the Act.

BUDGETS

The Agency Board has adopted a budget for 2022 which is included in the required annual on line reporting.

PROPERTY

The Agency does not own any property in its own name and has not addressed a disposition policy. Two active Agency projects as noted in operations above, where title is in the Agency's name as part of the Agency's providing of conduit financing and/or until the contractual benefits provided to the project company by the Agency under the periods and terms of the tax abatements are completed. Upon completion of the contractual benefits, title is transferred to the project company and the property is included on the taxable property tax rolls.

ANNUAL FINANCIAL REPORT

The Agency paid professional fees of \$12,352.00 and other administrative expenses of \$863.00 during the year. The Agency's fund balance increased and amounted to a \$153,821.00 balance on December 31, 2021.

NOTES AND BONDS OUTSTANDING

The Agency has no outstanding debt in its own name and no conduit debt as the project company is a lease project and has no bonds or notes outstanding at December 31, 2021.

COMPENSATION AND PROPERTY

The Agency has no paid employees and owns no real property in its own name as noted in the property above.


